Dear Brothers and Sisters in Christ,

I am confident of this, that the one who began a good work among you will bring it to completion by the day of Jesus Christ...for it is God who is at work in you, enabling you both to will and to work for his good pleasure (Philippians 1: 6; 2:13).

I write this letter with profound gratitude for your leadership within the Evangelical Lutheran Church in America. You have a very important responsibility as voting members for the spring 2009 Synod Assembly. In the midst of deep concerns about the world's ongoing wars, a global economic crisis, struggles within communities and families, and pending Churchwide Assembly decisions, we gather in hope, confidence (literally meaning "with faith"), and joy that God is at work among us.

As I travel throughout this church, people often say, "I have such hope when I hear about the church you describe to us." What do I describe? A church whose mission and ministry inspired the ELCA's new tagline: "God's work, our hands." A church excited about becoming fluent in the "first language of faith," the language of Scripture. A church that takes its time to listen deeply before making difficult decisions. A church committed to ending two major diseases of poverty: malaria and HIV/AIDS. A church with congregations that are vibrant centers for evangelical mission. A church sought by young people because it "matters and makes a difference." A church known for its generosity and long-term commitment to people affected by disasters. A church that accompanies partners, both close to home and throughout the world. A church that is "marked with the cross of Christ forever [and] claimed, gathered, and sent for the sake of the world."

You, your congregations, and your synod are part of God's work throughout this church. The Affirmation of Christian Vocation in *Evangelical Lutheran Worship* asks, "Sisters and brothers, both your work and your rest are in God. Will you endeavor to pattern your life on the Lord Jesus Christ, in gratitude to God and in service to others, at morning and evening, at work and at play, all the days of your life?" The response is my prayer as we gather for the 2009 Synod Assemblies:

Almighty God, by the power of the Spirit you have knit these your servants into the one body of your Son, Jesus Christ. Look with favor upon them in their commitment to serve in Christ's name. Give them courage, patience, and vision; and strengthen us all in our Christian vocation of witness to the world and of service to others; through Jesus Christ our Lord. Amen (Evangelical Lutheran Worship, p. 84).

God's blessings to you as you gather for your Synod Assembly. Listen for descriptions of this church as you worship, greet friends, pray for God's presence, and discuss and make decisions about matters that are important to this church. As you gather, recall Paul's words to the Corinthians:

Such is the confidence that we have through Christ towards God. Not that we are competent of ourselves to claim anything as coming from us; our competence is from God, who has made us competent to be ministers of a new covenant, not of letter but of spirit; for letter kills, but the Spirit gives life (2 Corinthians 3:4-6).

Compassionate God...Use Our Hands

“...moved with compassion, Jesus stretched out his hand and touched him... Mark 1:41

Prologue

As I begin this report (a short story of eleven chapters) for the 2009 Pacifica Synod Assembly, it is in the early days of the Season of Epiphany. The Gospel of Saint Mark is unfolding before us in the lectionary readings for our Sunday worship. Jesus is beginning his ministry, according to the language of this evangelist, in ways that are leaving the people “amazed.” I was especially moved this year, as I sat with this short Gospel, by the story appointed for the Sixth Sunday of Epiphany, where Jesus allowed a man afflicted with the contagious, deadly disease of leprosy to come near and kneel before him. We know this man should have kept his distance. We know most people would have turned and gone the other way if they saw such a person coming their way. We know how marginalized and ostracized people suffering from this debilitating and disfiguring disease were in that time and throughout human history. “If you choose,” the man said, “you can make me clean.” And Saint Mark tells us that Jesus was moved with compassion, with pity, with a caring emotion that came from deep within his own being and soul, and then he did the most unthinkable thing... Jesus stretched out his own hands and touched this leprous man and said to him, “I do choose...” As I read and reread that passage, contemplating this year of preaching from the Gospel of Saint Mark, thinking how I would address this story on a Sunday in the middle of February, and knowing that the theme of the Pacifica Synod Assembly had been set months before inviting a compassionate God to lead our hearts and hands and lips into compassionate living, doing, speaking, I, too, like the crowds that surrounded Jesus in the early days of his Galilean ministry, was amazed and moved and filled with thanksgiving. This is the way God loves me. This is what God is willing to do with me and for me every single day. Those same hands are stretched out in my direction now. That same choosing is choosing me. “Be made clean,” Jesus said to the leper. And he says it to me every day, every day, every day.

Could there possibly be any person on this earth that Jesus does not choose to love and touch and forgive and heal? We know the answer in our hearts and in our minds, “No, of course not! The love and the mercy of God is for all people and every person.” While society sets its boundaries as to how close a certain person may get to another, sometimes for good reasons and sometimes for poor reasons, God chooses not to be separate from anyone.

Toward the end of my reading of the short Book of Mark, I came upon the three different endings of this unique Gospel. While we cannot be certain how he ended his writing or even who it was that wrote which ending, we know the words point us to Jesus and lead us in our own discipleship. In one of the endings, Jesus sends out his followers to go from east to west with the sacred and imperishable proclamation of the love of God... the compassion, the mercy, the forgiveness, the promise, the hope, the eternal life and unbounded relationship with One whose arms and hands and heart is stretched out to us and to all.

Now we come to this assembly, the twenty-second such gathering of the Pacifica Synod of the Evangelical Lutheran Church in America (ELCA). We are called to come in great number and crowd together around Jesus, humbling ourselves before him, desiring just one word of care, perhaps seeking

his touch, hoping his outstretched hands might even include his embrace, and desperately needing his healing and compassionate heart. We are called to come to this assembly to be inspired and nurtured and refueled. We are called together to make important decisions for the synod and the ELCA that reflect the ways and the will of God. We are called to come together in Riverside so that we may be sent forth into all the synod and all the world with hands and hearts and lips of boundless, bold and grace-filled compassion.

Chapter One—The Book of Faith

Last May, in Synod Assembly, this synod voted to become a **Book of Faith Synod**. Several of our churches followed suit and have since become Book of Faith congregations. A Book of Faith team has been established and is diligent in its work of launching this initiative in this synod. They will have a report in this notebook and a presence in our assembly. We are also looking for others to join this ministry team. It has been uplifting to travel about the synod and hear the lay and ordained leaders referencing the Book of Faith initiative, opening meetings and gatherings with both Holy Scripture and with prayer. I trust other congregations will become part of the Book of Faith initiative this year.

Chapter Two—Pacifica Synod Staff

Everyday I am thankful for the staff members of the synod and the ELCA that serve so capably, faithfully, courageously, sacrificially and effectively. They are **servants of Christ and his church**. They lead with grace and commitment. This synod is in good hands under their ministry and missional work. We have had several changes. We give thanks for those who have moved to another vocational calling. We welcome with great joy the newest additions to our synod staff, the **Rev. Heidi Hester and Mr. Greg Shepherd**. We await, as of this writing, several more positions to be filled as the ELCA is assisting Pacifica in a search for a Director of Evangelical Mission, along with part-time support staff. As these staff changes are being made, our ministry descriptions are changing, too. At the assembly, we will share with you the current ministry descriptions and areas of work for each of the synod staff members. Some are full time employees and others part-time. For these people of faith who work with hearts and hands of compassion and care, I am most grateful. With their names are some of their key areas of ministry along with the year they began their work in this synod.

Chapter Three—New Ministries in Pacifica

When we lost the ministry of Lutheran Church of the Cross in Riverside, we lamented the closing of that congregation. After several years of efforts to determine how we could use the buildings and property for a new ministry, it was decided we needed sell the site. Again, we lamented as we lost this mission location within this synod. However with those funds, new life and ministry has been emerging from around the Pacifica Synod, springing up in several locations in a variety of languages. This continues to be one of our greatest joys within the Pacifica Synod. Currently, the Pacifica Synod congregations use **15 languages and dialects** regularly in their worship services.

Chapter Four—Day-by-Day

The day-by-day work for this synod is constantly changing and challenging. In some ways, it is like ministry in every other level of the church... joyful and fulfilling on many occasions, and sometimes sad and painful. We live with the annual rhythms of events, tasks, and duties that are the ongoing work of the Synod Staff, Synod Council, Conferences and Deans, and Ministry Teams. We prepare for assemblies and conferences, meetings and gatherings, and all the programs, plans and agendas we have on our calendars. At the same time, we address and respond to the many needs, invitations, expectations and critical moments in the life of our congregations and rostered leaders. We travel and attend meetings, gatherings, consultations and symposiums near and far. **Each day is always full.** There is never a time where we want for something to do. No two days are ever the same. The opportunities for hopeful proclamation and compassionate hands and hearts are always before us as we live with and address the multi-faceted opportunities for ministry.

Chapter Five—Concerns of the Whole Church

As one of the 65 synods of the Evangelical Lutheran Church in America, the Pacifica Synod shares in the ministry of our denomination week after week. We have been a faithful part of the ELCA. Over the years, we have sent from 53% to 56% of our mission support dollars for the domestic and global mission of the whole church. People from the Pacifica Synod serve on churchwide boards and commissions. Along with other synod staff members, I, too, have been very involved in a variety of capacities within the life and ministry of the ELCA. **It is always a privilege to work with other leaders from across the wide spectrum of this church as it carries out its diverse and outreaching mission.**

Some of the most important issues that we face as members of the ELCA are the ways we address the **economic downturn**. With fewer dollars being given, there have been reductions in ministry in many places. Positions are ending, retiring staff members are not being replaced. The eight ELCA seminaries and the 28 universities and colleges have been dramatically affected. Percentage-wise, ELCA congregations were already giving considerably less than they did 20 years ago, and now it has been difficult to maintain even that level of giving with the present economic shift. Together we bear the

burden and strive to work in close partnership with the churchwide expression and other synods, agencies and institutions of this fine church.

In August, the **Eleventh ELCA Biennial Churchwide Assembly** will be held in Minneapolis. During that assembly, many decisions will be made for the future direction and mission of the church, including a vote on the proposal to enter into a **full communion relationship with the United Methodist Church**. If we approve this ecumenical relationship, we will then be in partnership with six churches (currently we are in full communion relationships with the Episcopal Church USA, Presbyterian Church USA, Reformed Church in America, United Church of Christ and Moravian Church). The ELCA continues to lead the way in establishing full communion relationships with other Christian Churches in North America.

The long anticipated Social Statement, *Human Sexuality: Gift and Trust*, is now before us, along with two other documents prepared by the Task Force for the Study of Human Sexuality—the *Report and Recommendations on Ministry Policies*. The Social Statement will require a two-thirds majority vote of the 1045 voting members in order to be approved. The *Recommendations on Ministry Policies* now requires a simple majority vote, however that in itself is already been debated in many places throughout the church. These documents are all easily downloaded from the www.elca.org website. I recommend that each voting member at this synod assembly download those documents and read them carefully before coming to our synod assembly. Please bring copies with you, either printed or in your laptop. In the weeks ahead, the 12 voting members from the Pacifica Synod who have been elected to attend the Churchwide Assembly will be meeting in preparation for that gathering.

Many other important decisions will be made in other synodical assemblies and the churchwide assembly, keeping always our focus on Christ, the cross, Holy Scripture and the missional calling we all have to reach out with the message and hope of the Good News of the Gospel.

Chapter Six—Companion Synods

We were blessed this past year with the visit of newly elected **Bishop Thomas Tsen** of the Basal Christian Church of Malaysia (BCCM), one of our two companion synods. It was the first official visit from the BCCM to Pacifica (Pacifica people have been to their church on the northern tip of Borneo two times in the past nine years.) We have also stayed in regular e-mail communication with the leadership of the **South West Synod of the Ethiopian Evangelical Church Mekane Yesus**, especially as they are building their new building and looking for ongoing support from Pacifica and our B2B2B fundraising appeal. Unfortunately, this past year, our synod did not send a delegation to Ethiopia and we did not have visitors from their church here. We hope for more opportunities to connect with these partners, our sisters and brothers in the faith, with whom we share our Lutheran heritage.

Chapter Seven—Lutheran Center for Mission & Learning

At the end of April 2008, we moved into the **Lutheran Center for Mission & Learning (LCFML) in Santa Ana**, the new home of the Pacifica Synod. On May 3, 2008, as the concluding service for our synod assembly, we dedicated the building to the glory of God and enjoyed a wonderful afternoon of food and hospitality and fellowship. The new building has been a great blessing for this synod. This past year we have worked through most of the small details that needed to be addressed as we took ownership of the completely remodeled building. Along the way, the LCFML building committee (led by Jerry Engelhardt, Darrel Tuntland, Tom Shanks, Rod Anderson, Pastor John Knudson and several synod staff members) had a very good relationship with our architect, David Keitel; our project manager, Jim Korona; our construction manager, Jon Robinson, and our on-site supervisor, Dan

Egema. In the end, a beautiful, sturdy, well-furnished and up-to-date facility became the centering place for the administration of the Pacifica Synod, as a well as a place that has provided already many opportunities for classrooms and education, meeting rooms and mission planning, counseling space and pastoral care, places for inspiration and contemplation. We have hosted groups from all over the ELCA, from the Church of Denmark, ecumenical gatherings, many educational events and workshops, meetings of all sizes including some congregational council meetings in the evening, weekend retreats for church councils and the Women of the ELCA. There have been celebrations and dinners and lunches and breakfasts. At our facilities in Yorba Linda, we hosted about 35 gatherings per year. In the new Lutheran Center in Santa Ana, in the first full year of occupancy, **we hosted 141 gatherings** wherein the staff provided hospitality and presence, refreshments and food, set up and take down. It has changed the ministry of this synod in some very positive and more demanding ways. The LCFML has indeed given us a “center,” a more spacious place out of which to operate day-to-day, and a more holy place to worship, gather, learn, envision and go forth. **Every Wednesday, at 11:30 a.m., a 30-minute Eucharistic service is held**, involving hymn singing, Holy Scripture, a brief meditation and Holy Communion. Any and all are invited

Chapter Eight—B2B2B

Our synod-wide effort, **Blessed to Build Two Buildings, (B2B2B)** intended to pay off the remainder of the Lutheran Center and at the same time assist our companion synod in Ethiopia to build their new training center for Lay Evangelists, brought in \$134,991 this past year. We give thanks for every congregation and person who helped to raise these needed funds. We also are grateful for those who continue to work on this important fundraising campaign in 2009 as both buildings, the Lutheran Center in Santa Ana and the building in Ethiopia, still require substantial funding in order that both synods will be debt-free by the end of 2009 with their new facilities.

Chapter Nine—The Synod Council and Its Weekly Work

The Pacifica Synod Council has put in another diligent year of hard work and fruitful accomplishment. Almost every week of this past year found members of the Synod Council working at the Lutheran Center with teams and task forces and synod staff members and volunteers. They have not only conducted the business of the church in their quarterly meetings, but members of Synod Council and special teams of people completely reviewed and revamped our bookkeeping systems, the synod policy and personnel manuals, and the ministry team structure of this synod. The members of the current Synod Council are listed beginning on page 5-22 of this notebook. We especially give thanks for those ending their terms of service on the synod council. They are the Rev. Molly Knutson-Keller, Mr. Loren Fry and the Rev. Bill Snyder.

Chapter Ten—The Call and Highlights of the Pacifica Synod for a Bishop

As I reviewed my calendar since our synod assembly in 2008, these words frequently emerged: ordination, installation, church council meetings, LCFML meetings, staff meetings, church anniversaries, planning meetings for synod assembly and professional leaders’ conference, travel, airport, ELCA Conference of Bishops, ecumenical gatherings and meetings, continuing education, overseeing the Parish Planning Process for several of our synod congregations.

More specifically, I also finished a term on the **Executive Committee of the ELCA Conference of Bishops** and was elected to begin a four-year term as a **Liaison Bishop to the ELCA Church Council**. I finished two years of participation with the **Task Force for the ELCA Study of Human Sexuality**. I am a **board member at Pacific Lutheran Theological Seminary** in Berkeley and a **Convocator at California Lutheran University** in Thousand Oaks. Of the many **Ready Benches** our

Presiding Bishop, the Rev. Mark Hanson, has established within the ELCA, I have been asked to sit on two—one addressing the issues of **immigration** and the other advocates for **peace in the Middle East**.

Every day of this year past was a great day in some way or another. A **few of the highlights** for me would include

- ✦ a record number of ordinations in this synod that bring new pastors to the Pacifica Synod.
- ✦ a invitation by Roman Catholic Bishop Silva in Hawaii to be part of the anniversary celebration at Kalaupapa on the island of Molika'i.
- ✦ settling in at the Lutheran Center for Mission & Learning.
- ✦ A visit from Bishop Thomas Tsen from our Companion Synod in East Malaysia.
- ✦ a three week trip to Rome, Jordan, Israel and Palestine with the ELCA Conference of Bishops.
- ✦ Re-instituting the Parish Planning Process with several congregations.
- ✦ Reconnecting with many Asian Bishops and other church leaders at the Asian Lutheran International Conference in Hong Kong.

Chapter Eleven—On a Personal Note

This year marks my **eleventh year** as the Bishop of the Pacifica Synod. Next year, this six-year term will end on July 31, 2010. That means an election for synodical bishop will take place in our May assembly next year. Fifteen years ago, this synod set a three-term limitation for the Office of Bishop in the Pacifica Synod. During the summer, while taking some sabbatical leave, I will be in the process of discernment regarding my calling as the Bishop of the Pacifica Synod, as well as my intentions regarding the next chapter of my ordained ministry in this church. In the fall of 2009, I will announce my intentions.

As just stated, I will take some **sabbatical** time this summer, weaving into that time away a trip to New Orleans to be part of the ELCA National Youth Gathering in July and a longer journey to Minneapolis to be a voting member at the ELCA Churchwide Assembly. I will also participate in an educational and cultural pilgrimage to Turkey in late June and early July.

Our **family** was blessed again this year with the wonderful gift of another grandchild. Erik joined his sister, Helena, and our daughter (Erin) and son-in-law (Malte). Erin works full time as a mother and part time as a Speech Therapist and her husband is an attorney. They live and work in San Diego. Our daughter, Annie, continues her vocation in the Neuro/Trama ICU at the UCLA Medical Center. Our son, Adam, travels back and forth from Northern Uganda with his work with the NGO, Invisible Children (IC). He is often back in the U.S., working with IC in their office in San Diego. My spouse of 37+ years, Rhoda, an elementary school educator, is currently working as a Reading Coach/Consultant with the Anaheim City School District.

Epilogue

The Evangelical Lutheran Church in America summarizes its mission and ministry with the phrase, **God's Work, Our Hands**. Every day there are more and more images of how that happens in our world because of the love of God and the discipleship of the people of God. We are gathering in Riverside to focus on the compassionate mercy of God to all people and how God privileges us to use our hearts and hands and lips and legs to be about the grace and love and peace of God.

It has been a year of great blessing for me to work with and among the leadership of the Pacifica Synod! My work has been focused on a few specific projects:

1) **Conference Deans:** We have continued to work together to bring clarity to the role of the dean and to lift up the role of the conference. At last year's synod assembly each conference had the opportunity to gather and reflect on three questions:

1. *What opportunities for mission do we have that are unique to our setting?*
2. *What special gifts and resources can each of our congregations offer?*
3. *What can we do together that we are unable to do as individual churches?*

Some of our work together this year has been to look for ways the Deans can support the conferences as you continue to explore and respond to these questions and continue to seek ways to participate in God's mission in your own local setting.

2) **Synod Council:** Part of my work has been to assist the Council to examine its structure and function. We have redefined and broadened many of the positions on council by identifying specific duties for them, such as serving as members of committees and task forces so that the communication link between council and its sub-groups is stronger. We have also defined the role of the Conference Representatives to Synod Council as being responsible for communicating with the conference dean and/or lay chair more regularly; the purpose is so that conference reps have more information about what is happening in their conferences when making decisions on behalf of the synod. We still have some work to do in terms of finding ways to efficiently manage the administrative aspect of Synod Council meetings, but we are making progress here, too. Our goal is to carve out more time to attend to the *mission and learning* aspects of Synod Council's responsibilities.

3) **Synod Council "Sub-groups"** (Ministry Teams, Committees Task Forces): One of my tasks has been to "take inventory" of the many groups that carry out the work of the synod. We identified factors that lead to effectiveness, established some basic operating principles for each of these types of sub-groups, reviewed the charters, and made a number of changes in terms of purpose and function. *Check out the synod website "Who We Are" link to learn more about the work these amazing volunteers are doing, and especially to learn about how synod Ministry Teams can be a resource for your congregation or conference ministry initiatives.*

God has blessed this synod with gifted and dedicated people who serve as rostered and lay leaders, who worship in our churches, and who do God's work with their own hands... thanks be to God!

The responsibilities of the Pacifica Synod Youth Ministry Network are the following:

- To provide training, support and resources to those called by the Spirit to lead youth, children and family ministry
- To develop leadership that will equip parents and caring adults to nurture the faith of youth, children and families
- To network youth, children and family ministry leaders from congregations of the Pacifica Synod for mutual support, inspiration and shared programs

To accomplish the above the following ministries are offered the youth ministers of our synod:

- Four regional networks that meet monthly under the direction of Rick Schowalter. There is a North Network that meets in Banning, a Central Network that meets in Escondido, a South Network that meets in La Mesa and an Orange County Network that meets in Fullerton. The purpose of these network meetings is primarily mutual support however there is also a lot of shared ministry that takes place and the distribution of resource information. Pastor Judi Miller, Blanche Holland and Rob Horne are leaders in these networks. A youth ministry network also meets in Hawaii independently of the others.
- The Peer Ministry Retreat that teaches the mechanics of building quality relationships in a ministry context. This retreat is offered in cooperation with Camp Yolijiwa of the LRCC.
- Youth Ministry Training (YMT) event at California Lutheran University. This retreat was eliminated this year because of a conflict with scheduling and the Western States Youth Gathering. However YMT is again scheduled this year. This youth ministry training is offered over 4 tracks which can be taken each year the training is offered. After completing all 4 tracks the youth minister is honored as a "Recognized Youth Minister of Region 2 of the ELCA".
- Lutheran Youth Organization (LYO) event that takes place during the Synod Assembly and continues the day following at an event called "IT" which is the largest youth ministry gathering offered our youth through the synod. Three officers are elected at this LYO event to represent our youth at National Youth Gatherings and this event also taps into the ministry potential of our youth as they come to the LYO event with display boards that tell of their ministry efforts. Terri Robertson of Peace Lutheran in Corona helps to coordinate our LYO ministry.

There are many other youth events that are communicated and supported by our networks. Many of our youth ministries will travel to New Orleans this summer to attend the National Youth Gathering. All other events are communicated through an e-mail network that shares important events and network news. Sonshine Conference #1 and West San Diego Conference #2

The Sonshine and the West San Diego Conferences do their conference work together. There is a remarkable collegial spirit shared within the two conferences. The rostered leaders gather every Wednesday for lectionary study, Word and Sacrament worship, and discussion. It is not unusual to have twenty or more pastors present at these meetings.

The pastors' weekly discussions vary considerably depending upon concerns and interest. During the past year, once a month, we have focused on mission in the San Diego area. The guiding question has been: how might we do ministry more effectively as Lutheran Christians in our communities.

The first Wednesday of the month is always "Deans' Day." This is an opportunity to catch up on synodical and conference news as well as for the different congregations of the two conferences to highlight any areas of ministry that are significant and important to be shared with one another.

In addition to these weekly gatherings, the two conferences meet twice a year with pastoral colleagues from the Lutheran Church-Missouri Synod. In October 2008, participants explored the respective traditions of the ELCA and LCMS and examined how we have gotten to where we are today. In May 2009, Bishop Murray Finck and President Larry Stoterau of the Pacific Southwest District of The Lutheran Church--Missouri Synod will address the question, "Is the Lutheran Heritage Still Relevant for Ministry?" The tentative topic for our October 2009 gathering is "New Perspectives on St. Paul."

The Sonshine Conference welcomed Pastor Dan Roschke as the new pastor of Shepherd of the Valley Lutheran Church-La Mesa. The West San Diego Conference welcome Pastor Daren Erisman as the interim pastor at Our Savior Lutheran Church- San Diego. The two conferences said farewell and Godspeed to three trusted colleagues: Pastor Truls Pearson resigned from Our Savior Lutheran Church-San Diego to accept a call to Trinity Lutheran Church-Santa Barbara; Pastor Doug Knutson-Keller resigned from College Lutheran-San Diego to accept a call to Gloria Dei Lutheran Church-Olympia, Washington; and Pastor Molly Knutson-Keller resigned from Lutheran campus ministry at San Diego State University as her husband begins his new ministry in Washington and where she will be on leave from call in order to spend more time with their two young children.

The collegial spirit of these two conferences is astonishing! This spirit was evidenced throughout the year as almost every congregation in the two conferences, in addition to five Episcopal congregations, participated in the "Fifth Annual Hotter Than Thou Chili Cook-Off" to support Lutheran/Episcopal campus at San Diego State University, raising a record \$38,000. In addition to the support of campus ministry, congregations support the Third Avenue Charitable Organization (TACO) at First Lutheran both financially and with volunteers. Four of our congregations (Clairemont Lutheran-San Diego, St. Mark's Lutheran-Chula Vista, College Lutheran-San Diego; Lemon Grove Lutheran) house offices for various programs of Lutheran Social Services.

We pray for God's blessings as we are called to do ministry to San Diego city and county through the gifts of Word and Sacrament and service.

The team will coordinate its work with the synod staff, the Synod Council, the PALLMM (Preparing Adult Lay Leaders for Ministry and Mission) program, and other related ministry teams of the synod.

Cherish Our Children Ministry Team

In May 2009, the Pacifica Synod enters its third year as a Cherish Our Children Synod. Officially adopted at the 2007 Pacifica Assembly the resolution: “**RESOLVED**, that the Pacifica Synod of the ELCA will adopt the Cherish Our Children Initiative, and will establish a Cherish Our Children Ministry Team, reporting to the Bishop and the synod council, charged with implementing the ELCA Message on Commercial Sexual Exploitation” has a goal of 50% of congregations involved by 2012. As a Synod, the progress we have made thus far is:

In August, 2007, Amy Hartmann, ELCA Diaconal Minister and National Director for the non-profit Cherish Our Children Ministry based in St. Paul, MN, came to Pacifica to lead the initial training event for Synod Staff, Synod Council and interested pastors and adult lay persons. That weekend, Synod Council adopted a Cherish Our Children Ministry Team description and a committee was formed from the training session and began to meet: Rev. Judith Miller, Rev. Brian Taylor, Ms Caroline Anderson, Ms Terri Robertson, and Dr. Norm Beyer. In November, Caroline Anderson and Pastor Judi made a presentation to the Pacifica WELCA Assembly and WELCA adopted its own resolution similar to the Synod.

By January of 2008 the Team had met several times, conducted training sessions by phone with Amy Hartmann, designated Rev. Judith Miller as Chair, written a purpose statement, produced an Enrollment Document for congregations, produced information packets that were distributed to all congregations at Synod Assembly in May 08 (packets not taken as Assembly were mailed to each congregation), led an information session at Assembly and prepared for and announced three training sessions around the synod for congregational teams. Several congregations attended training at Peace Lutheran in Corona, CA. In November, another training was conducted at First Lutheran in Vista, CA at the Pacifica WELCA Assembly - representing an additional twenty to thirty congregations. To date, nine congregations have either sent in Enrollment Forms, donations, indicated some degree of participation in, or desire to begin, the ministry:

To stir up within the Pacifica Synod compassion and response for those who are poor, hungry, homeless or otherwise lacking the resources for basic human needs.

A few key highlights *from the last year* of this Ministry Team's work are:

- We shared with other synods our experiences developing a Hunger and Housing video communication tool for Pacifica.
- We have been preparing to welcome the Tour de Revs in 2009. Tour de Revs is a 100 day bike ride to benefit world hunger and to promote wellness. Three ELCA pastors are riding a single tandem bike across the country and will be stopping in Pacifica on July 15.
- We promoted the resource called "Taking Root: Hunger Causes, Hunger Hopes", a colorful and compelling ELCA World Hunger curriculum for children and youth. It includes five sessions each for three different age groups.

For the coming year, this Ministry Teams plans to focus on:

- Developing a hunger and housing internet resource.
- Organizing a welcoming event for the Tour de Revs.
- Collecting and sharing resources with congregation members who are looking for new ways to think about and respond to human suffering.

Immigration/Border Concerns Ministry Team

The mission of this Ministry Team is to engage the Pacifica Synod in faithful response to the Biblical mandate to welcome the stranger among us.

Responsibilities:

1) To support programs and efforts that serve the needs of immigrants and displaced persons through such programs as Lutheran Refugee and Immigration Services.

- 2) To advocate hospitality, compassion and safety for the immigrant “in our midst.”
- 3) To educate Pacifica Synod congregations and members about immigration, border and amnesty issues in response to the prophetic Biblical challenge to welcome the stranger.

A few key highlights *from the last year* of this Ministry Team’s work are:

The Ministry Team met 5 times in 2008, and has worked on the following items:

- Designed a resolution supporting the principle of Family Unity in immigration reform for last year’s Synod Gathering, which passed.
- Maintained a list of resources for congregations and individuals to use on the Synod’s web site: www.pacificasynod.org/Immigration
- Maintained communications with partners working in immigration concerns, including: Lutheran Immigration and Refugee Services, Interfaith Coalition for Immigrant Rights, Survivors of Torture, International,
- Sponsored Raleigh Deffenbaugh, Executive Director of LIRS, with the Synod for a two-day-long workshop with rostered leaders and an evening with lay members.
- Participated in an inter-agency conference on detention practices and abuses.
- Co-sponsored the 15th annual Posada Sin Fronteras (Posada without Borders) at the border fence with Mexico in San Diego.
- Offered leadership at 3 congregations for adult education opportunities around immigration.
- Hosted an information booth at the 2008 Synod Gathering.
- Sponsored a workshop at the Synod Gathering on Family Reunification Principals in immigration reform.

For the coming year, this Ministry Teams plans to focus on:

Goals of the Ministry Team for 2009 and 2010.

- 1) Pursue making the Synod Banquet at the Gathering into an educational event for hunger and immigration concerns. The thought is to obtain the menu well in advance and research the stories those ingredients have to tell about hunger and immigration. For example, a fruit salad might contain information about the places those fruits are grown, if migrant labor is used in producing them, ways in which the system might be exploiting migrant labor, etc. Hunger issues might trace the path of the beef on our plate, how cattle consume 30% of all corn that is raised, and the exchange value of the proteins/calories few to cattle verses the protein/calories of the meat end product. These might be at each plate for banquet participants to read and take home.
 - a. Georgina will inquire with Helga at the Synod about creating this opportunity
 - b. Mike will present this idea to the Hunger Committee to partner with us
 - c. Team members will each take one menu item to research, if this is a go
- 2) Put an article into the Synod newsletter explaining what has happened with the construction of the border fence here at Friendship Park in San Diego, raising questions about the wisdom of continuing the heavy use of resources in this way along the rest of the border.
 - a. Bill will fashion an article out of what Pastor John Fenistil has written
- 3) Pursue the idea of a study, beginning with our synod and then perhaps expanding to the wider USA, on nativism/tribalism and the damage such policies cause to others. First step is to identify and approach possible funders, and outline such a study. Purpose would be

to raise self-awareness of the ways we function in comparison to the gospel challenge that we are all global citizens in the kingdom of God.

- a. Mike will approach Paul Oas about spearheading such a project
 - b. Bill will investigate some possible grant options for funding such a project, and touch base with the ELCA offices about participating.
- 4) Legislative advocacy. Challenges members of the synod present at the Gathering to participate in advocacy with public policy makers on behalf of immigrants through legislative post cards to be passed out at tables at the Gathering. Primarily focus on detention issues.
- a. Bill and Kathi will research (perhaps through LIRS) what legislation may be pending about that time.
- 5) Involving new and different people on the ministry teams of the synod. Encourage the Synod Council to prepare and use a time/talent type sheet at the Synod Gathering, identifying needs within the Synod structure and Ministry Teams, that participants will be challenged to complete and offer during a worship event at the synod. Also to be used in the annual conference gatherings with the Bishop.
- a. Gerogina will present this idea to the Synod Council
- 6) Request a 15 minute time slot on the synod gathering agenda to present real stories from the detention system, partly to inform about the resolution on detention that will be presented
- a. Bill will make request to the Synod planning committee
 - b. Kathi and Bill will design the presentation, either will live guests, or pre-recorded interviews or stories
- 7) Develop a resolution for the synod gathering on the inhumane and unconstitutional practices and conditions in detention centers, and speaking out against the construction of the proposed CCA center in Otay Mesa, which is suppose to become the largest in the country. A “background” document might be attached to the resolution or available on Synod Gathering tables.
- 8) Bill and Kathi to design a resolution, and run it by the team in the next few weeks. The Synod deadlines for resolutions in Feb. 20, but we would like to submit it a week or two before that. We will consult with LIRS and other partners on framing such a resolution.

- Immigrants who are abused and exploited throughout the world and in our own land
- God’s guidance and wisdom for policy makers who are seeking constructive reform in immigration policies of our nation

the front porch difference

Now in its eleventh year, Front Porch, created in 1999 by California Lutheran Homes and Community Services and two other long-standing, not-for-profit organizations whose constituencies were of Methodist and California Teacher's Association backgrounds, continues to preserve, strengthen and expand not for profit missions by assuring two necessities for success: (a) resources for effective service delivery, and (b) the ability to be "doing good," while also "doing well" [Mission AND Margin]! Since the inception, three other organizations have chosen Front Porch as the place to preserve and strengthen their missions; they are: National Housing Ministries and Brookmore Housing Corporation (Baptist affiliated), and Sunny View Lutheran Communities and Services [Sunny View Retirement Community and Sunny View- West].

Even as Front Porch allows organizations to preserve, strengthen and expand their missions and build much needed financial and management capacity, it simultaneously retains each participating organization's corporate status, religious affiliation, identity, constituent base, unique program capacities, endowments and other philanthropy.

Today, the Front Porch system has grown to include eight organizations directly utilizing Front Porch as their parent system, 17 other not for profit organizations utilizing Front Porch as their management agent, and two for-profit corporations geared to serving persons 55 years of age and up.

Front Porch is Southern California's largest nonprofit provider of senior living communities. Headquartered in Burbank, the organization is made up of 11 full-service retirement communities in California: The Alhambra (Alhambra); Carlsbad By The Sea (Carlsbad); Casa de Mañana (La Jolla); Claremont Manor (Claremont); Fredericka Manor (Chula Vista); Kingsley Manor (Los Angeles); Sunny View Lutheran Home (Cupertino); Villa Gardens (Pasadena); Vista del Monte (Santa Barbara); Walnut Manor (Anaheim); and Wesley Palms (San Diego). Front Porch also owns two independent (55+) retirement communities in Louisiana and Florida. The Front Porch affiliate, CARING Housing Ministries, manages 42 affordable housing communities in California and Arizona.

Two major expansions are underway – the re-development of Walnut Manor into Walnut Village (Anaheim), and the first U.S. style retirement community for persons 55+ in Mexico, Luma (Puerto Vallarta).

In 2008 the Center for Technology Innovation and Wellbeing was incorporated through support from California Lutheran Homes to foster emerging technologies for improved living among older adults.

Because of the financial strength of Front Porch, many of the resources of California Lutheran Homes are available to pursue qualitative programming in behalf of the CLH communities operated through Front Porch, including:

CHAPLAINCY Chaplaincy is provided to all California Lutheran Homes' communities and to other communities that have partnered with Front Porch.

CENTER FOR SPIRITUALITY IN AGING The California Lutheran Homes' Center for Spirituality in Aging continues to bring immeasurable value to the lives of those we serve, and to have significant impact upon the entire long-term-care delivery system in California and beyond. The Center is responsible for research, education and advocacy in the areas of spirituality in long-term care/retirement living and community-based services. The Center is under the direction of The Rev. Nancy Gordon, with the Center's Founder, The Rev. Donald R. Koepke, continuing to serve as Director Emeritus.

THE CLH AUXILIARY For decades, the CLH Auxiliary has been a leader in improving resident life at CLH communities through volunteerism. Now, the Auxiliary reaches out to affordable housing communities, as well, including those sponsored by CLH and those managed through Front Porch. The Auxiliary continues to be a major provider of volunteers who staff the CLH Hospitality Centers at Synodcial Assemblies and District Conventions.

AFFORDABLE HOUSING Long a part of the CLH mission, affordable housing remains a primary emphasis under Front Porch. CLH serves as a sponsor for South Bay Retirement Residence in Compton, Pilgrim Tower in Los Angeles (serving primarily the deaf elderly), and St. John's Manor in Glendale, AZ. Additionally, CLH supports the work of

CARING Housing Ministries through Front Porch, which includes 42 affordable housing communities serving the elderly, low income families, persons with developmental challenges, and persons with chronic mental illness. CLH and Front Porch are currently working with Lutheran congregations in numerous geographies to utilize land resources for the provision of affordable housing.

THE FRONT PORCH ART GALLERY The Gallery was initiated by CLH in 2002 and exists to showcase the creative talents of residents, staff, and members of the local communities in which CLH and Front Porch services are provided. The Gallery is an example of how CLH extends beyond its original mission of providing senior housing, health care, and related services to enriching lives by celebrating people's artistic expression. Through a partnership with the Pacific Homes Foundation, the Front Porch Gallery established a permanent home at Carlsbad By The Sea in 2005.

SUNNY VIEW Lutheran Communities and Services Sunny View Lutheran Communities and Services (Cupertino, CA) is the newest Front Porch partner, joining CLH as the second Lutheran affiliated (ELCA/LCMS) social ministry organization to choose Front Porch as the way to preserve and strengthen its mission into an uncertain future.

LUTHERAN PLANNED GIVING PARTNERSHIP In 2008, CLH remained a primary "funder" and charter member of the Lutheran Planned Giving Partnership, building stewardship across the Pacifica and Southwest California Synods.

CENTER FOR TECHNOLOGY INNOVATION AND WELLBEING The Center was birthed by a grant from CLH in 2007. It is designed to create, support, and enhance emerging technologies in the areas of health and residential services. The Center is involved in building public-private partnerships to fulfill its mission. Front Porch continues to breathe new life into what CLH has done well for more than sixty years. The Church can rest assured that the CLH future has been secured for decades to come, at a time when many are wrestling with survival.

In April of 1958, CLEF, (California Lutheran Education Foundation) appealed to the congregations of California saying, *"We in the West have the privilege of helping to create a new college. It is an investment in our Church, our Community, our Nation, and our Youth. If we move forward together we cannot fail; if we do not we cannot succeed."* We have succeeded and along the way gained new partnership with congregations throughout Region 2. Now on the verge of our 50th anniversary California Lutheran University is proud of the partnership in ministry that has grown through the years, and looks forward to the next 50 years as we serve the youth of *"our Church, our Community, and our Nation."*

In the early days of this ministry cooperation took hard work. CLEF brought together congregations of the ELC, UELC, ULCA, Augustana and ALC church bodies. In many ways their efforts were unprecedented. Funding for the ministry of California Lutheran College came from national and district church budgets and congregational benevolence. The UELC even asked for \$5 from each confirmed member! Together they formed a partnership called the "fair share goal." It is that partnership of congregations and their ownership of CLC that has brought us to today.

This past September the largest freshman class in CLU's history arrived on campus. Applications for fall have exceeded last year by 31%. Our students come from 44 states and 54 countries. 91% of our students share \$17.1 million dollars in financial assistance. We have come a long way from those students who began in the chicken coops of the Pederson ranch. Our reach has extended far beyond the Conejo Valley and our alumni serve the church, communities, nation and world.

This past September I accepted the call to serve as the Director of Church Relations. It is a position I accepted in large part because of the commitment of President Chris Kimball that CLU is university of the Church. As an ELCA pastor since 1985 and a graduate of Lutheran institutions of higher learning I am convinced of the importance of the ministry of our 28 colleges and universities. I am privileged to be able to join with you in this partnership that is making such a difference for our students but also for our Church.

We know how CLU has benefited from the support of Lutheran congregations. That partnership began so long ago continues and CLU will always understand itself as YOUR University. As we begin the celebration of our first half-century we ask that you continue to remember CLU as a resource for your congregation as well as a partner with you in sharing the Good News of God's love in Jesus Christ.

Inter-Lutheran Emergency Response Team (I-LERT)

Each judicatory office participated in the Great Southern California Shakeout, part of the state's annual emergency preparedness exercise, by following earthquake procedures and implementing their emergency plan. This afforded them the opportunity to demonstrate their preparedness training, review and practice their plan. Areas of deficiency were noted and are being addressed.

Under the leadership of LSS-SW's staff, I-LERT developed a strategic plan for 2009 that involves establishing and training county I-LERTs. These teams will be able to respond in their geographic regions in a pre-planned and coordinated effort. They will be connected to LDR and its partners in their region. Two training dates are scheduled—September 12 and 26, 2009. 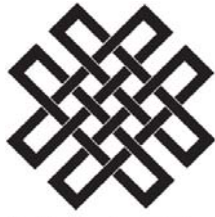

LSS-SW actively participates in local Voluntary Organizations Active in Disaster (VOAD) and is viewed as a key faith-based provider of disaster preparedness and response services. The agency was asked to represent the Lutheran community and serve as disaster response experts in the formation of a San Diego Faith-based Coalition to more effectively respond to disasters. Staff facilitated a national ELCA Consultation on Disaster Preparedness for the Poor that developed initial plans for serving this vulnerable population.

The agency provides a dynamic competency-based training program that enables congregations, groups and community organizations to develop effective strategies for preparing and responding to disasters within their communities and nationally. Staff conducted 26 preparedness trainings or workshops with more than 600 participants and 56 congregations or community groups represented. If your congregation has not taken advantage of this program, stop by the LDR table to get more information and sign-up for a training session. **"It is better to have a plan that you don't need, than to need a plan you don't have."**

LACE is an organization created for individuals who serve in the areas of adult education, youth and family ministries, confirmation ministries, and children's ministries and are interested in lifelong faith development. Volunteers, pastors, youth directors, children's directors, parents, grandparents are invited to become a part of the Lutheran Association of Christian Educators. LACE consists of individual members and congregational memberships. In some areas of Region 2, like the state of California, there are chapters. Chapters are LACE members that get together and share faith stories, resources, and support each other. Each LACE Chapter is required to have at least two members from different congregations and meet together at least four times a year. Chapter meetings consist of resource sharing, prayer time together, devotions and lots of laughter and fun. Chapters offer informative workshops that encourage Christian educators to keep researching, to keep developing and nurturing their own faith life and to encourage one another along the way. San Diego area chapters are sponsoring the Fifth Annual Christian Educators Training Event on September 19, 2009 at the Pacifica Synod offices in Santa Ana. Each year LACE recognizes an outstanding Christian educator. The recipient of the 2008 LACE Educator of the Year Award is Teresa Kaldor. Teresa is the Christian Education Team Leader at Calvary Lutheran Church in Solana Beach, California. LACE President Diane Shallue presented the award to Teresa on January 30, 2009 at the ELCA Youth Ministry Network Extravaganza in New Orleans. Teresa was chosen for her active leadership in the field of Christian Education. She began her work in Christian education by volunteering to help with Vacation Bible School when her son was four years old. Eventually, she became the Director of Christian Education at Pilgrim Lutheran Church in Indianapolis, Indiana before moving to southern California. In her current congregation, she also serves on the Protection of Minors Committee (which designs and promotes safety protocol and training.) Teresa is also a part of the Vision Team (which is bringing a more youth and family oriented vision to Calvary Lutheran.) She also participates in the Small Group Ministry subcommittee. Teresa is passionate about helping families nurture their children's faith; cross-generational learning opportunities, and still loves working with Vacation Bible School.

LACE members are spread out across Region 2 with the highest concentration in the state of California and with growing numbers in Colorado, Arizona, Nevada, Wyoming, Utah and New Mexico.

Compassionate God, Use Our Hands . . . In 2009, the Lutheran Office of Public Policy - California (LOPP) marks the 25th year of service as a ministry of public policy education and advocacy, operating as a partnership of the Pacifica, Sierra Pacific, and Southwest California Synods, and the ELCA's Church in Society Program Unit. Founded as the Lutheran Office of Governmental Ministry in 1984, under the theme of *Set Free to Serve*, our hands (and voices) are joined in a common effort to participate in the public arena with and on behalf of "the least of these," those who experience poverty, discrimination, and violence. Our freedom in Christ and our gratitude for God's redemptive love impel us to embrace the Gospel values of equity, harmony, healing, restoration, and reconciliation. Our mission, guided by official ELCA social statements and messages, is to serve the church as we step forward together as a "public church which witnesses boldly to God's love for all the God has created" (a strategic direction of the ELCA).

The state budget and three statewide elections, with numerous ballot propositions, defined most of the work of LOPP in 2008. LOPP provided ballot analysis and selected recommendations (opposing measures which threatened housing and state funding for programs serving people in poverty). The ongoing structural state budget deficit was already eroding health and human services – the safety net for the poor and people with special needs – when the economic recession accelerated in the fall, shortly after a record-setting budget stalemate. Facing an estimated \$42 billion gap between projected revenue and expenditures for the next 18 months, a special session of the Legislature reached a controversial February agreement that included spending cuts, tax increases, and borrowing, and a special election on May 19. Protecting health and human services and the safety net (including housing and nutrition programs) is an even more urgent priority for LOPP in 2009. The links between poverty, crime, and violence, and California's costly, overcrowded prison system, are getting attention from LOPP and others as the ELCA moves to develop a new social statement on criminal justice. The anticipated revision of the ELCA social message on immigration is also expected to give further policy guidance on an important issue. Care for creation receives ongoing attention, especially in the area of climate change and green jobs. We were pleased to support passage of the landmark SB 375 in 2008, which links carbon reduction goals with land use and transportation planning.

LOPP operated in 2008 with a budget of about \$130,500, of which \$105,700 was provided by the ELCA Church in Society Program Unit (primarily ELCA Hunger Program funds allocated to address systemic causes of hunger and poverty). In 2008, Pacifica Synod's partnership support was \$7,626. Sierra Pacific Synod (\$6,000), Southwest California Synod (\$6,953), and congregational, Women of the ELCA, and individual gifts make up the balance. Churchwide Hunger Program support has been reduced by 50% in 2009, the LOPP director position was reduced from full time to half time beginning May 1, and operating expenses are being curtailed. Larry Dodson (Chair), Kaz Oshiki, Rev. Michael Hagenow, and Rev. Bill Radatz represent Pacifica Synod on the LOPP Policy Council. Rev. Gordon Peterson is the synod staff representative, and Violet Quist represents Pacifica Women of the ELCA. Thanks be to God for this faithful support and participation! The director and Policy Council welcome invitations to your congregation, and your visits to the State Capitol.

Lutheran Social Services of Southern California

Founded in 1946, Lutheran Social Services of Southern California, a social service agency of LC-MS and ELCA churches in southern California, has been reaching out to people in need, as it “celebrates the love of Christ for all people through acts of service”.

Lutheran Social Services of Southern California currently provides direct services for low income and homeless individuals and families in seven area offices and several more sub offices in six counties, from Ventura County to San Diego County. The services include emergency assistance, including food pantries and rental assistance; employment assistance; homeless services; mental health counseling; minor home repair programs for seniors; senior companion programs; transitional housing for women and children and veterans outreach and support. A day program for people with developmental disabilities operates in Pasadena.

While many of our area offices have grown in their ability to serve more people, others have had to shrink, due to budget constraints. We have seen an increase of at least one-third or more hungry people coming to our food pantries just in the past three months. Although we have been able to serve the great majority of them, with the assistance of local food banks and the generosity of churches and retail food stores and restaurants, the food is often gone by Thursday. Some of our food pantries have reduced their hours to four days a week. We have been able to connect veterans with jobs and job training in Van Nuys. We have helped seniors get their homes repaired inside and their yards cleaned up. We have helped families stay together through our counseling programs. We have given some homeless individuals and families a place to stay overnight and help to connect with public programs to help them with money and medical care.

This past year, LSS/SC has visited many Lutheran churches to share information about our work and to request help supporting our mission. We have a new web page, lsssc.org, where anyone can see what we are doing and where we are doing it, can read news about us and our programs, and even donate online. The Rev. Bob Warren served us well in these areas. In mid February, the Board of LSS/SC appointed Patricia Digre interim President of the agency, upon the resignation of Rev. Warren. Having served previously on the board, and more recently as Program Administrator for LSS, Pat’s many years of social work experience at the administrative level makes her a good fit for the agency during this time of transition.

On a final note, we would like to express our deep gratitude to all those who have volunteered their help to LSS/SC. We have been constantly encouraged by those who come forward willingly to give their time and their talents to help others. Although times are very difficult in the present economic climate, we have seen an increased spirit of giving of time and resources that heartens us as we seek to move forward in fulfillment of our vision that “all people will have the opportunity to live and work in a community with dignity and hope.”

Report to the Pacifica Synod Assembly from the Mission Investment Fund of the ELCA

The Mission Investment Fund of the ELCA continues to serve this synod by providing vital loans for capital projects to new mission congregations, established congregations, and ELCA-related ministries. MIF is able to fund these loans through the sale of investments to ministries and congregation members.

More than **800 MIF loans** totaling nearly **\$500 million** are at work today in ELCA ministries throughout the United States, the Virgin Islands and the Caribbean.

In the Pacifica Synod, 19 congregations and ministries currently have Mission Investment Fund loans totaling \$14,786,617, while many individuals, ministries and the synod have investments in the fund totaling \$10,695,470.*

MIF serves ELCA ministries. In addition to the ministry loans and investments that it offers, the fund provides consulting services to ELCA congregations through its church building consultants and staff architects. The consultants review plans for building projects and assist with church construction financing. Staff architects provide initial schematic design proposals that congregations can take to local architects. The consultants and architects' services are provided **at no charge**. MIF's area representatives are available to meet with congregations and ELCA-related ministries related regarding the loan and investment opportunities offered by the fund.

Has your congregation invested? Have members of your congregation invested? Join the thousands of individuals, ELCA congregations, ELCA-related ministries, and synods – [including our synod] – that are earning interest on their investments as they help to build the Evangelical Lutheran Church in America. Your participation enables the fund to continue this vital ministry.
